Meeting called to order at 4:30 PM.

Tour of the AMSC with David Voetmann

President's Report at 5:02 PM - Dr. Singh

- Dr Singh explained the Dear Colleague letter from the Department of Education and its implications re Title VI and 14th Amendment.
 - 2023 Supreme Court decision: race cannot be used for acceptance decisions at colleges.
- The college was renamed to Edmonds College 6 years ago, and as of April 1 our divisions will be called Schools instead of divisions.
- Explained the function of the Dept of Ed: controls Pell Grants, student loans, office of civil rights complaints. Half of the staff of DoE will be laid off soon.
- The college can keep operations as usual, but needs to examine programs that may not be within compliance, such as the Men of Color program.

Auditor Report at 5:10 PM - Vine Dahlen

Finance Committee 5:25 pm - Ryan Davis

- Summary of Statement of Activities (as of December 31, 2024) The Foundation experienced a net loss of \$76,824, a shift from last year's \$258,252 profit. This reflects a 9% decrease in total revenue (\$769,116) and a 44% increase in total expenses (\$845,940).
 - Revenue Highlights:

- Individual donations rose by 11% to \$135K; Foundations and corporate matching gifts also increased (↑ 9% and ↑ 89% respectively); Significant declines were seen in corporate giving (↓ 25%), grants (↓ 67%), and club/association contributions (↓ 41%); Total operating income dropped 11% to \$406K; Investment income declined slightly by 8% to \$363K; Special event revenue was \$0 (previous year: \$950); Miscellaneous income jumped to \$2.5K (↑ 1029%).
- Expense Highlights:
 - Operating expenses were \$275K (↑ 3%), with notable increases in personnel (↑ 19%) and community partnerships (↑ 199%); Donor cultivation saw a decrease (↓ 19%); Fees and admin costs were down 10%; College support and scholarships rose significantly to \$486K (↑ 52%), driven by major increases in scholarships (↑ 23%) and emergency funds (↑ 3088%); Grants distributed and college program transfers decreased (↓ 320% and ↓ 17%, respectively)
- Key Takeaways:
 Increases in individual, foundation, and matching gift support.
 Declines in corporate, grant, and club-based funding.

- Many students on campus aren't aware that there are scholarships or don't know how to fill them out
- Some suggested improvements to increase awareness: more information on the website/better navigation, info sessions as part of orientation, other ways to accept applications/in person application sessions, information in Advising sessions, simplification of the application as much as possible to help students (especially ELA students)

Executive Director's Report 5:45 pm - Tom Bull

- The May Board meeting has been rescheduled from May 13 to May 22 to accommodate a special partnership event.
- On May 14, the Foundation will collaborate with the Black Box Theater to host a rehearsal performance, showcasing a new partnership aimed at enhancing student engagement and community outreach.
- The Board meeting schedule for the upcoming fiscal year has been finalized and will be distributed following approval by the Executive Committee.
- Work is currently underway to finalize the updated College/Foundation agreement, with further updates to be shared at a future meeting.

- Overall Fundraising Progress
 - As of February 28, we received a total of \$583,575 in gifts. This amount includes \$212,000 in previously committed funds that we successfully secured through our efforts. Notable examples include contributions from former board members and gifts supporting STEM initiatives.
 - Major highlights
 - 3 major individual gifts of \$70,000, \$40,000, and \$15,000.
 - Donor Engagement & Retention
 - New donors acquired
 - 42 representing \$48,000+ link to goals
 - Retention rate of existing donors
 - 164 donors retained, 39% retention rate
