DIRECT TRANSFER AGREEMENT BETWEEN THE WASHINGTON COMMUNITY COLLEGE SYSTEM AND THE UNIVERSITY OF MONTANA-MISSOULA

The Washington Community College System and The University of Montana-Missoula hereby enter into the following agreement to promote the successful transfer of students between institutions. This transfer agreement ensures that a student who completes an Associate of Arts or an Associate of Science degree from the Washington Community College System will have satisfied the lower division general education requirements at The University of Montana-Missoula.

Details of the agreement are as follows:

- 1. A minimum 2.00 GPA or higher is required for all college work attempted.
- 2. Students will receive junior-level standing with 60 or more transferable semester hours.
- 3. Remedial courses (courses numbered below 100) are not transferable to UM.
- 4. A grade of C- or better is required for any courses that are used to satisfy the prerequisites or required courses in a major, minor, option or certificate.
- 5. Completion of the AA or AS degree will only satisfy UM's lower division general education requirements. Upon transfer to UM, students will be required to complete the upper division writing requirement.
- 6. This agreement does not guarantee admission to The University of Montana-Missoula or to any specific program or major. Students who transfer within this agreement must still meet requirements in their chosen major, minor or professional program.
- 7. Each institution agrees to notify the other of changes in curricula, degree requirements or admission requirements.
