Edmonds Community College Foundation Campaign Feasibility Study Executive Summary

December 2018

Introduction

Edmonds Community College Foundation (Edmonds CC Foundation or Foundation) engaged The Alford Group (Alford or Counsel) to test the feasibility of a major philanthropic campaign for \$10 million to launch a Promise Scholarship Program, and to complete construction of the Science Engineering and Technology (SET) building.

The Campaign Feasibility Study (Study) was conducted between June 2018 and December 2018. A nine-member volunteer Feasibility Study Committee, co-chaired by Wendy Popke and Dick Beresford, was formed to provide general oversight for the Study process.

The Alford Group discussed Edmonds CC Foundation's plans with 40 individuals through 30 personal interviews as well as meetings with three staff leaders of Edmonds Community College and the Foundation.

The Feasibility Study focused on variables that when combined should predict relative campaign success. These include Edmonds CC Foundation's *organizational image*; the *project appeal* for which Edmonds CC Foundation wishes to seek gifts; the capacity and willingness of prospective donors to provide sufficient *financial support* for the campaign; the identification and availability of key *leadership* for the campaign; the organization's *internal readiness* to launch and support a major campaign effort and the philanthropic *climate and timing* of the proposed campaign.

Key Findings

Organizational Image: Edmonds Community College enjoys strong name recognition, a positive reputation among those familiar with it, and has a cadre of supporters who are knowledgeable and enthusiastic about the quality of its work. The strengths the College is most known for – affordable and accessible educational institution, talented faculty and staff, and strong academic and workforce development opportunities – will continue to serve the College well into the future. While Edmonds Community College has strong name recognition, the variety and quality of its academic and technical programs are not as widely known as they could and should be. However, the introduction Dr. Amit Singh as the new College President presents tremendous awareness-building opportunities moving forward.

Project Appeal: Both proposed campaign components – completing the SET building and launching the Promise Scholarship Program – resonate with potential donors. While very different in nature, both are seen as meeting critical educational and workforce development needs in the region. However, while each component is valued, The Alford Group does not recommend combining them in one campaign effort for two primary reasons: the two components are seen as too disparate to fit within the umbrella of a

combined campaign and each component is at a different level of "readiness" for inclusion in a campaign.

Volunteer Leadership: The Alford Group found a number of supporters and potential campaign volunteers who are passionate about Edmonds Community College's mission and programs. In general, College Trustees, Foundation Directors and the Feasibility Study Committee members are seen as well-networked, well-respected, philanthropic, and would be able to influence others during a campaign.

Staff Leadership: While many interviewees had not yet met Dr. Singh, Counsel found him highly engaging, very excited about the future direction of the College and highly motivated to support the philanthropic efforts of the Foundation. He understands he has a key role to play in raising public awareness and obtaining major philanthropic funding for the College. Foundation Executive Director Brad Thomas is viewed as a strong asset and will be an essential leader in the campaign effort. He is well regarded for his leadership, relationship-building skills, and dedication. He is seen persistent – someone who will do the work needed to engage new donors. Additionally, Dr. Carey Schroyer, the Dean of the Science, Technology, Engineering, and Math Division, has an exceptional ability to communicate excitement and passion for STEM education, and should be engaged in the campaign effort where appropriate.

Financial Support: Taking into account all of the information gathered during the Study, The Alford Group believes that up to \$5 million in gifts and pledges is an appropriate and achievable goal for an Edmonds Community College Foundation campaign at this time. Analysis of a campaign goal takes into account many factors including information gleaned directly and indirectly from interviews, discussions about other current and potential Foundation supporters who were not interviewed, the Foundation's growing philanthropic efforts, and The Alford Group's collective knowledge of and experience with local, regional and national philanthropic giving and trends.

More than other initiatives for which the Foundation has sought funds in recent years, STEM education (and the SET Building) creates the opportunity to engage selected members of the corporate community, particularly those with an interest in STEM-related workforce development. Philanthropic investment from the corporate sector will help to *unleash* campaign contributions from individuals and families. A significant number of individual interviewees indicated they need assurance that they would be *partners* in philanthropic support for the STEM program, along with the corporate community.

Internal Readiness: The Alford Group reviewed the ability of Edmonds CC Foundation to effectively support the increased fundraising activities of a major campaign effort, including data management, staffing, and the potential amount of time required for successful management of the campaign. The Foundation has a clearly defined annual fundraising program, dedicated staffing and strong fundraising infrastructure. The donor database is sufficiently robust to support the additional information requirements of a campaign; however, the Foundation would benefit greatly from a thorough evaluation of the database, followed by necessary global clean-up activities. An estimated additional 1.0 FTE will be needed to provide high level administrative and campaign coordination support.

Climate and Timing: The Pacific Northwest region is currently enjoying a strong and active philanthropic response to pressing community needs. The only consensus one can



identify these days in terms of the National political climate is that it we are living in a period of uncertainly. On the one hand, uncertainty can be an unfavorable condition when it comes to philanthropy, as donors are generally more reluctant to make significant gift decisions when they feel uncertain about their own future. On the other hand, various causes are seeing a groundswell of philanthropic support as a direct reaction to recent national decisions. These donors are reportedly prompted by a sense of urgency to support organizations and missions that they perceive as vital to our society, under immediate or potential threat, and sound long-term investments. In any community, there are always multiple fundraising efforts underway. Two current or future campaign efforts were mentioned most frequently including:

Edmonds Senior Center/Waterfront Center – campaign Lynnwood Community Center – campaign

Summary and Overall Recommendation

The Feasibility Study findings confirm that several of the critical elements for campaign success are in place:

- Edmonds Community College has broad name recognition and a positive reputation among key constituency groups.
- There is keen awareness of the need for and value of STEM education throughout the country, and the benefits that state-of-the-art STEM educational opportunities will bring to regional students and employers. There is recognized urgency for moving forward with the SET building now – the project is 100% ready to go.
- Prospective donors recognize the value of supporting underserved populations with educational scholarships – it has long been a priority of the Foundation.
- Edmonds Community College has a cadre of committed volunteers willing to serve in a variety of campaign volunteer roles.
- The Foundation's annual fundraising efforts are growing and becoming increasingly sophisticated.
- There is some evidence of major gift capacity and propensity to support a future campaign effort among individuals affiliated with the College.
- The Foundation Executive Director is well regarded.
- The new College President is fully committed to a future campaign effort and ready to dedicate the resources necessary for success.

However, the Study identified several challenges that will hinder the success of a \$10 million combined campaign to complete the SET building and launch a Promise Scholarships program:

- The two campaign components are seen as too disparate to fit within an umbrella
 of a combined campaign they lack a *natural* unifying element. While each
 component is valued in its own right, combining them will likely dilute the other.
- Each component is at a different level of "readiness" for inclusion in a combined campaign. There is recognized urgency around the SET building component and the project is 100% ready to be included in a campaign. On the other hand, significant work is needed to further develop the Promise Scholarship Program



concept and how it will be implemented and sustained at the Foundation. This type of background work will increase donor understanding and confidence in the new scholarship concept.

• There is insufficient evidence of adequate financial support to fund both campaign components.

Based on these overarching findings and a thorough analysis of all elements of the Feasibility Study, The Alford Group recommends that Edmonds Community College Foundation immediately move forward with a "finish and furnish" campaign for up to \$5 million for the SET building. The campaign should include a strong focus on engaging the local and regional business community. It should be "fast-tracked" to match the urgency of the SET building construction timeline – approximately 18 months.

During the SET building campaign, the Foundation should create a detailed plan illustrating how the Promise Scholarship Program will be designed, implemented, and sustained. It is possible that once a strong plan is in place, the Foundation can initiate targeted major gift efforts with a limited number of selected individuals for whom scholarship support is their primary interest – even while the SET campaign is underway. If successful, these early gifts may set the stage for major fundraising to establish a Promise Scholarship Program at Edmonds Community College.

EDCC FOUNDATION BOARD OF TRUSTEES February 7, 2019 Meeting Report

- Two Impact Receptions were hosted this past fall Wendy Popke at the *Seattle Golf Club* and Sara Carter in her home. Each of the events welcomed between 20 and 30 guests and were a great chance to introduce new friends and re-introduce lapsed donors to the Foundation. In addition, the guests saw a presentation from a department of the college. The third Impact Reception will be hosted by Ken and Leslie Chandler on February 12, 2019, at *Bar Dojo*.
- Gala Sponsorship: Gala planning is well underway with just over three months to go. As the Foundation works toward a goal of \$125,000 in sponsorships (with an overall event goal of \$400K) sponsorships are taking center stage. Currently, \$103,000 in sponsorships have been confirmed, including *Premera* as our returning title sponsor though they have recently double their sponsorship investment to \$20,000. Seven of last year's sponsors have yet to confirmed their sponsorship commitment, and only seven available tables in the ballroom remain before the gala is sold out. As a reminder, that there will not be an auction at this year's gala, though there will be a new after party featuring the Edmonds CC Jazz Band, a no-host bar, a coffee bar, and a dance floor.
- The gala kick-off reception will be Wednesday, February 27, at *Scott's Bar and Grill*. This event will take on a similar format as last year's kickoff with invitations to sponsors, table captains, committee members, Foundation Board members, and college trustees to learn about the gala, goals for the event, table/audience development, and how to maximize the guest experience at the gala.
- Scholarship Dinner: The fourth annual Scholarship Dinner hosted by Nick and Caitlin
 Echelbarger will take place February 2, 2019, and will involve a wonderful dinner and brief
 updates by Nick Echelbarger and Dr. Singh. At this time, 12 couples are confirmed for the event
 with additional RSVPs expected this week.
- The 2019 Campus Giving Campaign kicks off January 22 and runs through February 15, 2019. This year's goal is to raise \$35,000 through payroll deduction gifts and one-time gifts from staff. The Foundation has 16 division meetings planned, a hot cocoa rolling bar, a s'mores cookout and various email and mailed communications planned. The Campus Giving Committee is made up of 18 dedicated campus members who participate in all aspects of the campaign and act as ambassadors for the Foundation.
- Planned Giving: Recently the Foundation launched planned giving website to provide information for those considering including EdCC in estate planning. Please be sure to check out this new educational resource.
- Thanks to a recent gift from Dr. Suzanne Poppema and Dr. John Cramer in the amount of \$100,000, the *Cramer-Poppema Endowed Scholarship* has been established and will provide scholarships for female students enrolled in STEM programs pursuing professional careers in the field.

• The Alford Group presented the findings from the 6-month long feasibility study including interviews of 32 of Foundation Board members, EdCC Trustees, donors, and community leaders at the Foundation's annual retreat January 11, 2019. The Foundation Board then discussed the recommendation to move forward with a SET building campaign. Following the discussion the board decided to create a Funding Options work group which will meet January 30 to discuss four funding options. The Foundation Board will meet again on February 15 to make a final decision on which SET building option in which to invest our time, talent, and resources.

- Shepherd's Village Ribbon Cutting November 18, 2018; The City of Lynnwood, Good Shepherd Baptist Church, Pallet, and the Jean Kim Foundation for Homeless Education partnered to create a six-unit, fenced-in community within walking distance of EdCC. Too often we look at education success beginning and ending with academics, but several factors are involved and need to be addressed as part of a more holistic approach. Shepherd's Village is a perfect example of removing critical barriers to learning. You can't learn if you're cold, wet, and wondering where your next meal is coming from. I am beyond pleased at the enthusiastic support this effort is receiving from all quarters.

- City of Lynnwood Annual Legislative Engagement November 19, 2018; This annual event included representatives from local, county, state, and federal agencies at Lynnwood City Hall.
- SBCTC Meeting December 5-6, 2018; EdCC hosted the *Washington State Board of Community and Technical Colleges* for the December meeting and presented an overview of the college as part of the agenda.
