- The incident at Corrections involving a faculty member is still being investigated. Administration and the Federation are working together to ensure that the faculty member's rights are protected.
- Last year, 2008, several members of the Humanities Division were told many by voice mail that they would not be returning in the fall. There were a number of negative consequences from these events, but the Federation hoped that the dismissals would not be repeated. However, over the last 2 weeks up to 8 faculty in the English department were told again many by voice mail that their services would no longer be needed. No reasons were given. This cannot be due to class cuts because other faculty will teach their classes. The Federation is attempting to contact all these faculty members to make sure they are aware of the benefits available to them.
- The Best Practices document, endorsed by the State Board in 2005, will be distributed to all faculty, administrators, and trustees. We need to see where Edmonds stands in relation to these recommendations.

WASHINGTON PUBLIC EMPLOYMENT RELATIONS COMMISSION (PERC) RULING

Subject

Reading and posting of the Washington Public Employment Relations Commission (PERC) Ruling, AFT Edmonds v. Community College District 23. Case 22084-U-08-5624

Background

As a result of Edmonds Community College's decision to not offer a quarterly employment contract to Ms. Margaret West in the spring of 2008, the faculty union filed an unfair labor practice charge. Ms. West was and is the President of the faculty union, AFT Local 4254. The Washington Public Employment Relations Commission conducted a hearing in which all parties presented evidence and arguments. The Commission ruled that the Edmonds Community College committed an unfair labor practice in violation of the State's collective bargaining laws.

The College was ordered to post – for 60 calendar days – a notice of the findings and to have the College's admission and statement of remedy be read into the record at the next regular Board of Trustees meeting. The order was posted on July 24, 2009.

Recommendation

The Washington Public Employment Relations Commission (PERC) Ruling for Case 22084-U-08-5624 will be posted on the Edmonds Community College campus for a period of 60 days beginning July 24, 2009, and will be read during the open public meeting of the Board of Trustees, September 28, 2009. Copies of the meeting minutes will be forwarded to the PERC compliance officer.

ESCO FACILITY IMPROVEMENT PROPOSAL

Subject

Consideration and approval of financing of ESCO energy conservation and facility improvement project.

Background

Being as Edmonds Community College wishes to become a "green" campus by not only reducing energy consumption but also by reducing production of carbon emissions into the atmosphere, the College contracted with an Energy Services Company (ESCO), working in partnership with State of Washington General Administration (G.A.) office, to conduct a preliminary greenhouse gas emissions inventory and self-funding facility improvements plan. This facility improvement plan has now been presented to the College, has been favorably reviewed by the G.A. office, had the estimated energy savings calculations verified by both Snohomish PUD and Washington Energy Services, and been reviewed by the college Business Office.

The ESCO facility improvement plan will meet the following college goals and values:

- Reduce energy costs ongoing
- Address high priority facility needs
- Maximizing systems life and reliability for critical college facilities infrastructure
- Provide a greenhouse gas emissions audit to serve as a baseline for emission reduction planning
- Provide a 100% self-funding and budget neutral package

Specific elements of the facility improvement plan are:

- Campus lighting replacement in Alderwood Hall, Seaview Gym and the Triton Union Building
- Install adjustable frequency drive on broken chiller compressor
- Repair outdoor air dampers in Lynnwood Hall
- Direct digital controls for North Brier Hall HVAC system
- Replace Central Plant old single condensing boiler with new staged boilers
- Optimize Central Plan chilled water
- Provide variable frequency drives to control Snohomish Hall supply fans
- Migrate server room to virtual servers

Project costs and benefits:

- Cost will be \$2,007,000 via State Certificate of Participation (COP)
 - less approximately \$550,000 incentives/rebates from SnoPUD & PSE
 - 10 year payback schedule

- 15 year lifecycle benefit (net, after debt service) to the college of >\$1,530,000
- Utility cost reductions of over \$120k per year
- Eliminates current financial risk of old systems, otherwise unfunded for replacement/repairs
- Reduces College Carbon Dioxide emissions by over 2.1 million pounds annually
 - Equal to roughly the annual energy consumption of 133 houses

Recommendation

Edmonds Community College recommends that the Board of Trustees adopt this resolution by approving the ESCO facility improvement proposal and financing plan.
