Declaration of Financial Exigency – Kevin McKay Attachment C	Kevin McKay presented a declaration of Financial Exigency for first consideration and discussion. The College is in the middle of unprecedented budget cuts and actions. We have been planning for an additional midyear unmitigated cut of \$1M, or 4%, and are now being asked by the State to go through a 6% exercise. We are being told to plan for an additional 10% cut in the first year of the new biennium and there is no certainty of what to expect in the second year of the biennium. The State Board for Community and Technical Colleges declared the system to be in a condition of Financial Emergency at the start of the current biennium and has indicated it will do the same for the coming biennium. The College is asking the Board to consider declaring a financial emergency to ensure the College has the maximum flexibility possible to contend with the rapidly changing financial landscape and the projected coming allocation reductions. The Board has previously discussed this potential action. Faculty and staff have been involved in this transparent process by submitting their ideas on how to address the budget cuts. Our college has a process where we have worked through all of our budget cut considerations using a series of values that have been continually repeated to the campus. Faculty and staff will be asked to provide other ideas during this process which includes surveying staff and faculty and providing road shows. As input comes in across campus through each division, the vice presidents bring the list of suggestions, ideas, options, and possibilities to President's Cabinet for further deliberation.		The College is obligated to provide the Governor through the State Board with a budget plan for both a (now) 6.3% reduction this (current) year and for an additional 10% reduction for the first year of the next biennium by September 30. Updates will be provided next month when this declaration is considered. The campus will have an opportunity for input during an upcoming all-campus forum before the Board is asked to take action.

AFT Local 4254 EdCC Faculty

In a few minutes you are going to consider making a declaration of financial emergency for the college. According to the agenda, the discussion will be limited to a few minutes. However, this is such a serious step with potentially serious effects on students and faculty that it's hard for me to know where to begin. The faculty – those few who know about this proposal - have instructed me to speak plainly, so here goes.

Why are you doing this now? As of this morning, no other college in the state, with the exception of Bates TC, has taken such a step. Not one. Faculty have been off contract. I know today is a contract day, but it's also a prep day, and many faculty may work from home. It's safe to say that many, if not most, faculty do not know about this proposal yet, and your action may look to them, regardless of your true intentions, as if it is being sneaked in under the radar while they were not under contract. You can declare a financial emergency anytime, next week, next month, November ... To consider this proposal today seems premature.

Also, tomorrow is *welcome back* day. What are you going to do? Usually the trustees attend the meetings and talk to faculty. What are you going to say? "Welcome back, and I hope your finances are better than the college's because you may be looking for a job soon?" Not much of a welcome.

At Bates TC, 40 faculty received RIF notices. The faculty passed a *no confidence* vote, and organized petitions and rallies with outside groups. Eventually the 40 were whittled down to 5. The exact status of those 5 is unclear, but what is clear is that labor/management relations have been very badly damaged. Although Bates gave the faculty more notice than you apparently are planning to give to Edmonds faculty, the process itself is so rushed and so obviously targeted against tenured faculty that it makes trust impossible.

We know that the financial situation is bad and getting worse, but at least let's sit down and look at all the options first. Treat the faculty like adults.

We like to ask ourselves about any proposal: is it good for students and is it fair for faculty. This proposal is obviously neither.

I assume you have studied the statute. The only defense the RIF'd faculty member has is to argue that he or she is not "right one" to be RIF'd but that someone else is. Think of the effect on morale by being forced to make that argument

We ask that you table this proposal at this time.

- Edmonds Career Access Program (EdCap) summer enrollment was twice last summer's total and the college is on target to equal or exceed last Fall's enrollment. They are hoping to hire a new EdCAP case manager this week to help with the increased amount of students. This program is for out-of-school youth between ages 16 and 21. The goal is to complete a high school diploma and begin work in a professional/technical area.
- Energy Management classes for Fall Quarter are all full and second sections have been added for all but one class.
- Energy students are going to work with the City of Lynnwood and City of Edmonds on an energy audit grant and will shadow auditors to learn more about the process.
- Culinary Arts if full for Fall Quarter with a waiting list of 15 students. The baking program has 18 students and since this is a cohort program, it's almost full too.
- Another new program, Event Planning, is really taking off with very high enrollment this quarter.
- Our Big Three: Accounting, Management and BSTEC have very high enrollment and high s/f ratios (average 27/1) and will continue to grow. We have added new classes in the last few days.
- We received a \$10,000 grant from the State Board to launch a Sustainable Business program. We will start in Business Management developing a Sustainable Business course.

- Claudia Levi is in Lille, France with 15 students on a study abroad program she helped organize.
- We are getting ready to launch "Quality Matters" an online course rubric. We piloted the
 program last year and want to move it out to all divisions now to get as many courses as
 possible Quality Matters certified. Andy Williams is the lead on this project and is a
 Certified Master Reviewer for Quality Matters. This rigorous program ensures all online
 courses are structured to meet minimum requirements and ensure they are set up for
 success.

Background

DECLARATION OF FINANCIAL EXIGENCY

Subject

Consideration of formally making a declaration of financial exigency.

Background

RCW 28B.50.873 provides an expedited layoff process applicable to tenure track faculty for use during a financial emergency. The State Board has authority to declare a financial emergency if there is:

- A reduction of allotments by the Governor
- A reduction of appropriated funds by action of the legislature
 - Within a biennium (adjusted for inflation); or
 - from one biennium to the next

The expedited process provides for limited appeal, consolidated hearings (if requested) and 60 day timeline from notice to hearing conclusion, for layoff of tenured/probationary faculty.

Given the unprecedented reduction in the state allocation to the community and technical college system this (2009-2011) biennium, the State Board did declare a financial emergency, authorizing individual colleges to follow suit. Edmonds has so far been able to avail ourselves of solutions to mitigate our portion of the system budget cuts without having to take this course of action.

However, with an additional mid-year allocation cut estimated at just over \$1 million for this fiscal year and facing a projected additional cut of as much as 10% (an additional \$2.6 million) in the first year of the coming (2011-2013) biennium, and with a great deal of uncertainty beyond the first year of the biennium, Edmonds is going to need a great deal of flexibility to find ways to mitigate the coming budget reductions.

By the end of this fiscal year (2010-2011), Edmonds will have taken over \$5.9 million in cuts to our state allocation, amounting to 22% of our state funding. This is no longer a matter of weathering a few difficult years, but now represents a fundamental change in the way we are funded as a state agency and will require a similarly fundamental change in the way we operate as a college.

The State Board has indicated they will again declare a financial emergency for the 2011-2013 biennium and many (of not most) colleges are likely to follow suit, of necessity. It is the opinion

of college leadership that Edmonds should also declare a financial emergency in order to ensure we have as many tools at our disposal as possible as we plan for the coming reductions to our operating budget.

We remain fully committed to the set of values which have been consistently used throughout these difficult times and decisions:

- Remember who we are and who we serve
- Minimize impact on student access/support
- Minimize impact on employees
- Ensure open communication and feedback (process transparency)
- Generate additional revenue as a first resort
- Look at all funds

As such, we do not take this step lightly. However, we believe it is entirely possible that reductions in staffing beyond normal attrition or early retirement may be required, depending on the nature and size of the coming budget cuts, and the college needs to be positioned to take those actions deemed necessary to best mitigate the coming budget reductions.

Recommendation

The staff of Edmonds Community College recommends that the Board of Trustees adopt the resolution authorizing the formal declaration of financial exigency.

WHEREAS the State Board has already indicated it will renew its declaration of financial emergency for the 2011-2013 biennium,

NOW, THEREFORE BE IT RESOLVED that the Board of Trustees approves the declaration of financial exigency for the remainder of the 2010-2011 fiscal year and the 2011-2013 biennium.

APPOINTMENT OF HEARING EXAMINER

Subject

Appointment of Hearing Examiner

Background

Due to lack of enrollment in the Theatre Arts program, President Jack Oharah gave written notice on September 22, 2010 of the intent to implement a Reduction In Force (RIF) of Ms. Joanna Goff's position as a tenured faculty member from the Theater Arts program. On September 30, 2010, Ms. Goff requested a hearing to appeal this decision.

Section 4.6.7 of the College's labor agreement with the Edmonds Community College Federation of Teachers specifies that the President of the College shall notify the Board of Trustees of this request for hearing, and request that the Board of Trustees appoint an impartial hearing examiner.

The College has consulted with the Federation of Teachers concerning this appointment per the labor agreement. Three potential hearing examiners were identified. The Federation did not object to any of them. Frederick J. Rosenberry, an arbitrator/mediator from Edmonds, Washington was one of the identified examiners. The Federation was not as familiar with Mr. Rosenberry as the other two possible examiners; however, Mr. Rosenberry's immediate availability for this hearing coupled with his solid reputation and experience as an impartial hearing examiner make this a good choice for the Board.

A summary of Frederick J. Rosenberry's professional experience is attached as page 2 of this Background Statement for reference.

Recommendation

The President of Edmonds Community College recommends that the Board of Trustees adopt the resolution authorizing the appointment of Frederick J. Rosenberry as hearing examiner for the Joanna Goff appeal of her proposed RIF.
