Residency for Tuition Purposes- Required and Supplemental Documents

Students who were classified as non-residents at the time of their admission may be eligible to establish residency for tuition purposes. To qualify, students must be able to document their "intent" to establish Washington as their permanent domicile (residence) at least 12 months prior to the start of the quarter for which they are applying.
